Prohibited products

Prohibited products are those products whose sale is strictly prohibited according to international and local laws. As a reference, it is strictly prohibited to sell illegal, unsafe or counterfeit products on all Linio platforms.

Restricted products

Restricted products are those products whose sale in a given country is subject to certain limitations, such as additional documentation and/or charges, all being the sellers' responsibility to clearly identify and consider. Please note that there is a maximum declared value which varies by country and the shipping method chosen by the customer (express or postal) 1, 2, 3.

This document lists product restrictions in Latin America and the countries where Linio International Marketplace operates for your convenience. The examples listed on this document are not all-inclusive and serve as an informational guide only. We encourage sellers to seek advice on export requirements and regulations from professional legal counsel. Further research on prohibited and restricted products and any consequences from the failure to follow such policies is the responsibility of the seller

Notes

- 1. The maximum declared value for all counties is set on local currency on this document. The currency conversion from USD to local currency could change as exchange rates fluctuate. Sellers are strongly advised to consult exchange rates frequently.
- 2. Please note that a cushion has been applied when defining the maximum declared value and the duty-free threshold in each country. This is a range between the values in USD and the local currency to safeguard against currency fluctuations as well as possible logistics and customs barriers. Each shipment should not add up to the maximum allowable shipment value by country.
- 3. All product prices on Linio are shown in local currency. Sellers are strongly advised to consult currency exchange rates frequently and modify their prices based on the latest USD exchange rate.

- 1. The maximum declared value for postal shipments to Peru is 2,000.00 USD (aprox. 66,700.00 PEN). Linio recommends a limit of 950.00 PEN for parcels with a low shipping fee to minimise the risk of a potential damage or loss.
- 2. For both postal and express shipments to Peru import duties are 0% for cellphones, tablets, laptops; 4% for all regular (non-restricted) products; 6% for toys, perfumes and makeup, plus 18% VAT. It is the sellers' responsibility to calculate these and add them to the final price paid by the customer. If the parcel is detained at customs sellers are responsible for resolving issues that may arise (less than 7% of postal parcels are checked at customs).
- 3. Restricted products require a statement signed by the client confirming that the product is bought for personal use only. Linio Peru is responsible for sending the statement to the client who needs to print it, sign it and send it (scan or photo) back to Linio. Once received, Linio sends it to DHL Peru so that the product can successfully pass through customs.
- 4. Cellphones, tablets, drones, and other Wi-Fi enabled products require a special permit from the Transport and Communications Ministry. Linio Peru has negotiated a deal with DHL Peru to take care of this permit. An additional cost must be considered when calculating the product price, currently being 18.00 USD as of May 2016.

- 1. Tax & Duties for both express and postal shipments to Panama are 17% on average, including Import Duties 10% and VAT 7%. All shipments pay Tax & Duties (no Duty Free exemption applies) and these vary depending on the product category. Before listing your products on Linio please ensure you consult Tax & Duties as well as further information on these by clicking here.
- 2. Shipments require a Health Ministry Certificate and Sanitary Registry number upon arrival. Expect 3-4 days of delay for clearance. The minimum broker charge for processing is 35.00 USD while payment for shipments from .01-5,000.00 USD may be USD 47.00.
